JUST TRANSITION FRAMEWORK IMPLEMENTATION FORUM

The Presidential Climate Commission has recently adopted a Just Transition Framework. This policy is built on a deep process of stakeholder engagement, and the development of a social compact around critical elements of the transition (e.g., decarbonisation combined with green growth, skills development, and social support).

As part developing the Just Transition Framework, a series of engagements were undertaken with eight (8) communities around South Africa which represent those, dependent on, and/or directly impacted by fossil fuel and energy value chains, including the imminent transition facing the broader economy.

The broader PCC outreach on the Just Transition was success in many ways, including:

- (1) Consolidating the views and concerns of affected communities and sectoral stakeholders regarding what constitutes a just transition and its principal elements.
- (2) Building trust and understanding between social partners and opportunities for further collaboration and dialogue
- (3) Establishing a consensus regarding the principal elements of a just transition which will be built into the national Just Transition Framework

Failure to sustain a coordinated response to climate change can be traced to several root causes, which inhibit the ability of South Africa to create and implement a just transition pathway:

- Failure to integrate climate transition planning into policy—consistently, coherently, across sectors.
- Lack of consensus among social partners, given historical inequalities, vested interests, and mistrust; and
- Lack of resources to undertake the just transition, including financial and human capacity.

The first two barriers reflect disagreements between economic actors regarding the nature and extent of climate action, regarding:

• The decarbonization pathway, considering implications for energy mix coal phase-out.

- Governance and capability in the public sector, in the wake of state capture.
- Ownership of resources (public versus private).
- The trade-offs between preserving natural capital and accelerating economic development; and
- The implications of climate transition for economic structure and racial transformation objectives.

The PCC informed by the initial engagements and feedback from various stakeholders has identified the need to continue to engage the communities and social partners in a second phase of its Just Transition Framework development and conduct dedicated Just Transition Outreach Engagements to bring to the forefront the benefits, timelines, opportunities, and change that the country will undertake to introduce a just transition. The purpose of this phase of community engagements is to:

- 1) Engage with community, youth and women's organisations in South Africa that are most affected by the climate transition to deepen dialogue around the just transition.
- 2) Starting and supporting social dialogue processes involving unions, communities, government, and business, with participation from investors and experts.
- 3) Building up to a conference of civil society groups and other social partners (including government, business, and labour) that focuses on the measures and capabilities.

As governments, environmental and health professionals, and scientists grapple with saving lives and finding solutions to deal with climate change and associated extreme weather events, the question of how to prepare for ongoing 'climate disruption' is a more significant challenge that we will have to face.

The consultation will also discuss South Africa's response to this challenge based on learning and recommendations that emerged from the previous phase of Just Transition Framework Consultations.

The intended outcome entails achievement of consensus—or at least sufficient resolve—between key stakeholders involved in the just transition, enabling a common set of objectives to be adopted and a coherent programme of action to be undertaken towards these objectives.
