### Presidential Climate Commission Just Transition Framework Consultation

The Presidential Climate Commission (PCC) is a multi-stakeholder body established by the President of the Republic of South Africa to build a social compact around the climate transition and advise the government on the country's climate change response and pathways, and particularly, on how to ensure that the transition process and outcomes are just. The PCC is co-developing a Just Transition Framework: a multipronged practical policy strategy to guide the implementation of necessary interventions across the short-, medium, and long-term to achieve a just transition for South Africa (aimed to be an inclusive and representative document).

To build consensus on this framework between the social partners, the PCC is holding a series of community engagements and consultations across the country. These consultations, undertaken in eight sites across South Africa that represent a range of the country's just transition issues, will feed into a multi-stakeholder conference on the just transition in May 2022, and the completion of the final Just Transition Framework document by mid-2022. We invite you to join the workshop in Carolina to add your voice to this important discussion.
